## **ROUTE TWO** – You must produce

- Three (3) documents from Group 2 comprising of;

  - > Two (2) further documents from Group 2a or 2b; one of which must confirm your current address and
- The recruiting organisation that is conducting the check will then need to conduct an appropriate External ID Validation search is used to check your details against their records to establish your name and living history footprint.

If you cannot meet the requirements of **ROUTE ONE** or **ROUTE TWO** your recruiting organisation will have a probing discussion with you to establish **why** you cannot meet these requirements.

## **ROUTE THREE – You must produce**

- ➤ Birth Certificate (UK & Channel Islands)- (issued after the time of birth by the General Register Office/relevant authority i.e. Registrars Photocopies are not acceptable) and
- Four (4) further documents from Group 2 comprising of;
  - One (1) document from Group 2a; and
  - Three (3) documents from Group 2a or Group 2b; one of which must verify your current address.

If your recruiting organisation is unable to validate your Identity through ROUTES ONE, TWO or THREE, the fast electronic application will have to be abandoned, you will have to complete a paper application, and you will need to go for fingerprinting by the Police.

You must be aware this will cause a considerable delay in the CRB application process and subsequently your recruitment.
